### **Building DEI Capacity**

#### **Conscious Conversations Training with Circle Up Education**

Twelve Valley Water staff members completed the two-part training series Conscious Conversations, provided by Circle Up Education on March 29 and April 10. Participants learned effective and proven techniques to interrupt unconscious and unintentional discrimination by learning to call people in versus calling them out. The intent of this training was to empower staff members to become active advocates and allies in advancing diversity, equity, and inclusion at Valley Water and beyond.

#### Racism Uncovered with Circle Up Education

On May 2 and 4, 19 staff members participated in the Racism Uncovered training series facilitated by Circle Up Education. This awareness-building session helped participants deepen their understanding of racism, implicit/explicit bias, power and privilege, as well as racial hierarchies. The goal of this series was to help participants better understand the dynamics of racism and the privilege-based power they can leverage to disrupt racism.

#### **Environmental Justice Training with the Shipley Group**

Thirteen Valley Water staff members completed a five-hour virtual introductory environmental justice (EJ) training on June 1, 2023. Participants gained a broad understanding of current federal and state EJ regulations and implications for agencies, learned about the EJ analysis process and documentation, and reviewed the community engagement process and strategies in alignment with EJ. The information gained was used to develop additional EJ resources for staff and strengthen current Valley Water EJ processes. A recording of the training and resources were also shared with all employees through News You Can Use, with an additional 21 views.

# REDI, ERGs and Valley Water Staff Attened Annual Government Alliance for Race & Equity Members Meeting

The Government Alliance for Race & Equity's (GARE) annual member's meeting was held in Oakland, California on June 14 and 15. Valley Water's Office of Racial Equity, Diversity & Inclusion (REDI) coordinated the

participation of a Valley Water group including employee resource group (ERG) leaders and Human Resources representatives to participate in this year's conference "Governing for All: California." This was a great opportunity for staff to learn and meet other DEI practitioners in the field from national and local agencies. Workshop topics ranged from building equity in budgeting, the importance of data to support DEI work and best practices to advance DEI in government.
