FEDERAL ADVOCACY EFFORTS

Meetings with D.C. Officials to Advocate for Shoreline Project Funding

On February 2 and 16, Valley Water held virtual meetings with officials at the U.S. Army Corps of Engineers (Corps) in Washington, D.C., to advocate for federal funding for the South San Francisco Bay Shoreline Phase I Project (Shoreline Project). Valley Water met with leaders at Corps Headquarters and the Office of the Assistant Secretary of the Army to request that the Corps provide \$91.2 million to the Shoreline Project, which would fill the current federal funding shortfall. Under the Fiscal Year 2023 Supplemental Appropriations Act, which Congress passed in December 2022, the Corps was given \$350 million to spend on projects that were originally funded under the Bipartisan Budget Act of 2018, such as the Shoreline Project. Valley Water had advocated for inclusion of these funds in the FY23 supplemental funding bill, along with passage of the Water Resources Development Act of 2022 to make the Shoreline Project eligible to receive these additional federal funds. The Corps is developing its work plan for these FY23 supplemental funds, which is expected to be released at the end of February. Valley Water will continue to advocate with the administration for the Shoreline Project to receive these funds.

Assemblymember Pellerin Introduces AB 939 Smart Financing for Valley Water Infrastructure

Assemblymember Gail Pellerin (D-Santa Cruz) has introduced a bill sponsored by Valley Water to amend the District Act to address several changes required to modernize financing mechanisms that will reduce the cost of infrastructure projects, clean up obsolete provisions, and address a sunsetting provision regarding per diem for the Board of Directors. The bill, AB 939 (Pellerin) was introduced on February 14, and will be referred to the appropriate policy committees in the next month. Staff will work closely with the author's office to advocate for the bill's passage.

Assemblymember Kalra Introduces AB 1469 to Assist Unsheltered People

On February 17, Assemblymember Ash Kalra (D-San Jose) introduced a Valley Water sponsored bill to expand the purposes of the District Act to better assist unsheltered people and to fulfill the agency's existing mission. The bill will enable Valley Water to provide resources for outreach, counseling, transitional housing, or other services for unsheltered people living on public lands and along waterways within Santa Clara County. The bill will be referred to the appropriate policy committees in the next month. Staff will work closely with the author's office to advocate for the bill's passage.

Director Beall Advocates for Valley Water in Sacramento

Director Beall was in Sacramento on February 16 and advocated for Valley Water's two sponsored bills and funding for priority projects. The Anderson Dam Seismic Retrofit Project, the Purified Water Project, and the South San Francisco Shoreline Project were all discussed. Staff is currently organizing a trip for the Board to Sacramento in May to advocate for Valley Water priorities during a crucial time when the State Budget and legislation are being considered.
