**NOTICE OF COMPLETION OF CONTRACT AND ACCEPTANCE OF WORK**

NOTICE IS HEREBY GIVEN by order of the Board of Directors of Santa Clara Valley Water District, State of California, pursuant to law, that work to be performed under the contract heretofore made and executed by and between Santa Clara Valley Water District, as Owner therein, and **Con-Quest Contractors, Inc., 880 Mitten Road, Suite 105, Burlingame, CA 94010**, as Contractor therein (Contractor), bearing the date **August 8, 2023** for construction of the Snell Pipeline Inspection and Rehabilitation Project, Contract No. C0698, and Project No. 95084002 and appurtenant facilities upon lands of said District known as **Snell Pipeline, which runs along White Rd., continues westerly along Aborn Rd to Thompson Creek, then southwesterly towards Niemann Blvd. and Daniel Malony Dr., then continues along Brigadoon Way, Silver Creek Rd., and Yerba Buena Rd., towards Sylvandale Ave. and Senter Rd., then along Skyway Dr., Snell Ave., and Martial Cottle Park, then crossing the Santa Teresa Hills and terminating at Santa Teresa Water Treatment Plant**, situated in the County of Santa Clara, State of California, was completed as called for and in the manner designated by the plans and specifications, by the Contractor, and the work was accepted by the District's Board of Directors on behalf of the District on **June 24, 2025**.

That the title of said District to the real property upon which said work and contract was performed is that of **easement, agreement, and in fee**, and;
