#### FEDERAL ADVOCACY EFFORTS

## **Board Approves Federal Funding Priorities in Advance** of DC Trip

On October 8, the Board approved the federal funding priorities for federal fiscal years 2025 and 2026. Staff will advocate for these priorities during the fall advocacy trip to Washington, DC, which will occur November 18-20. Key funding priorities include increased grant funding for Federal Emergency Management Agency programs that could support Valley Water flood protection or hazard mitigation projects in the future, increased funding for recycled water projects, and additional resources for the U.S. Army Corps of Engineers to continue the Shoreline Sunnyvale Study. Staff recommends new funding requests prior to each fall and spring advocacy trip to Washington, DC, which form the basis of our advocacy with legislators and officials during the annual budget process.

#### **BCDC's Draft Regional Shoreline Adaptation Plan**

On October 17, Valley Water submitted comments to the San Francisco Bay Conservation and Development Commission (BCDC) on the draft Regional Shoreline Adaptation Plan (RSAP), a comprehensive strategy aimed at guiding the Bay Area's response to sea level rise and other climate-related shoreline challenges. Developed to establish a unified, science-driven framework, the RSAP proposes strategies to address critical regional risks like flooding and groundwater impacts while fostering resilient ecosystems and safeguarding vulnerable communities. For Valley Water, the RSAP represents an important opportunity to collaborate on best practices and standardized approaches to shoreline adaptation, aligning regional efforts with local needs.

Valley Water's comments reinforce its support for RSAP's goals and emphasizes the importance of incorporating refined local data and clarifying model limitations to ensure the plan effectively supports Santa Clara County's resilience. Staff will be working closely with BCDC and other partners to implement a robust, adaptable response to the region's shoreline adaptation needs.

#### **Unhoused People & Environment Summit**

On October 11, Valley Water held the Unhoused People & Environment Summit in person at the Santa Clara Convention Center and virtually via Zoom. The summit brought together local leaders from Santa Clara County, South Bay cities, businesses, nonprofit service providers, and advocacy organizations, as well as representatives from the state and federal governments to discuss how to address encampments of unhoused people along Valley Water's waterways and how we can work together to address the challenges around homelessness in our region.

Chair Nai Hsueh and Vice Chair Richard Santos provided welcome remarks, which were followed by remarks from California Interagency Council on Homelessness Executive Officer Meghan Marshall, County of Santa Clara Board Supervisor Cindy Chavez, San José Mayor Matt Mahan, and Santa Clara Mayor Lisa Gillmor. The summit featured panel discussions on the impacts of encampments along waterways and opportunities for interagency collaboration. The panelists included executive leadership from the California Interagency Council on Homelessness, County of Santa Clara, City of San José, Destination: Home, and DignityMoves.

The summit had over 300 people in attendance, including elected officials from the County of Santa Clara, cities of San José, Santa Clara, Morgan Hill, Gilroy, Cupertino, Campbell, Palo Alto, Mountain View, and Town of Los Gatos, as well as staff from the offices of U.S. Senator Alex Padilla, Congresswoman Zoe Lofgren, Speaker of the Assembly Robert Rivas, State Senator Dave Cortese, Assemblymember Gail Pellerin, County of Santa Clara Board Vice President Otto Lee, and County of Santa Clara Board Supervisor Sylvia Arenas.
