- 2. Appendix Three, Schedule of Completion, paragraph #6, Project-Level Schedule, is amended to modify the "Completion Date or Duration from NTP" column for Task 1 through Task 10, from 24 months to 26 months.
- 3. All other terms and conditions of Agreement not otherwise amended as stated in this Amendment No. 1 remain in full force and effect.
