NOTICE OF COMPLETION OF CONTRACT AND ACCEPTANCE OF WORK

NOTICE IS HEREBY GIVEN by order of the Board of Directors of Santa Clara Valley Water District, State of California, pursuant to law, that work to be performed under the contract heretofore made and executed by and between Santa Clara Valley Water District (District), as Owner therein, and Con-Quest Contractors, Inc., 880 Mitten Road Suite 105, Burlingame, CA 94010, as Contractor therein (Contractor), bearing the date June 28, 2022 for construction of the Santa Clara Conduit Rehabilitation and Pacheco Sectionalizing Valve Replacement Project, Contract No. C0673, Project No. 95084002 upon lands of the United States Bureau of Reclamation (Bureau) known as Pacheco Conduit and the southern half of Santa Clara Conduit situated in the City of Gilroy in the County of Santa Clara; unincorporated Santa Clara County, and County of San Benito, State of California, was completed as called for and in the manner designated by the plans and specifications, by the Contractor, and the work was accepted by the District's Board of Directors on behalf of the District on June 25, 2024.

That upon said contract, Markel Insurance Company, 4521 Highwoods Parkway, Glen Allen, VA 23060 (Bond No. 4451812) was surety on the bond given by Con-Quest Contractors, Inc., the Contractor, as required by law;

That the Santa Clara Conduit and Pacheco Conduit are part of the Federal Central Valley Project's San Felipe Division that is owned by the Bureau;

That the District, pursuant to an agreement with the Bureau, operates and maintains the Santa Clara Conduit and Pacheco Conduit upon which said work and contract were performed; and

That the District's address is 5750 Almaden Expressway, San Jose, California 95118.
