# Directors and Senior Staff Engage with Partner Agencies, Regulators at ACWA Spring Conference

Several directors and senior staff attended the Association of California Water Agencies (ACWA) Spring Conference in Sacramento on May 7-9 to meet with partner organizations and state and federal regulatory agencies, as well as to learn from subject matter experts on issues of concern to the California water community. Valley Water attendees met with partners and regulatory agencies to identify opportunities for collaboration and advocate for shared priorities, including advancing the B.F. Sisk Dam Raise Project and the Healthy Rivers and Landscapes Program. The Office of Government Relations coordinates these side meetings and supports all Valley Water attendees at the conference.

### STATE ADVOCACY EFFORTS

### Valley Water Bill Proposal Held due to State Costs

AB 2409 (Papan) State Permitting Transparency was held by the Assembly Appropriations Committee due to state costs. This means the bill cannot advance further in the legislative process. The bill would have created a state permitting transparency website for water supply, flood protection, and energy reliability projects with an estimated cost of \$100 million or more. The bill was assigned a cost of \$387,000 in year one and \$230,000 in ongoing annual costs. The current state budget revenue shortfall resulted in hundreds of bills being held due to costs. Staff will continue to look for administrative, regulatory, and legislative solutions to the permitting delays that unnecessarily increase the costs of Valley Water projects.

#### **State Budget Process Continues**

On May 10, the Governor presented his May Revise Budget, which accounts for the latest state revenue estimates and updated Administration proposals for how to close a \$27.6 billion budget shortfall. The May Revise retained budget cuts to dam safety, sea level rise, and recycled water, and maintains the proposal to shift excess education revenue augmentation fund (ERAF) funding from counties and special districts to charter schools.

On May 29, the Senate and Assembly released their mutual budget proposal, which rejects the shift of ERAF funding as well as the cut to dam safety funding, and partially restores a modest amount of funding for recycled water and sea level rise. The Legislature has until the June 15 constitutional deadline to pass the FY 2024-25 State Budget. Staff continues to strongly advocate for protecting existing funding for Valley Water projects and programs. Staff efforts for increasing funding for water supply, flood risk reduction, and environmental protection are now focused on a climate resilience bond proposed for the November 2024 statewide General Election.

#### **Proposition 1 Homekey Program Funding**

Proposition 1 (March 2024) allocates up to \$4.4 billion to enhance state programs aimed at expanding access to mental health care facilities and substance abuse treatment centers. In addition to mental health and substance abuse services funding, Proposition 1 allocates \$2 billion for the Homekey Program for the conversion of hotels, motels, and other structures into various types of housing units, as well as the construction of new residential units. Of the \$2 billion, \$922 million is allocated for individuals who are either experiencing homelessness or are at risk of homelessness. On May 15, staff met with the Homekey Program manager who confirmed that Valley Water is eligible for Homekey funding, but also confirmed the money can only be spent on permanent supportive housing and that a funding source for operating the facility for 55 years must be identified.
