STATE ADVOCACY EFFORTS

Legislature Grapples with Budget Deficits

The Legislative Analyst's Office (LAO) has stated that the state budget deficit is up to \$78 billion while the Governor's Department of Finance has indicated the budget deficit is \$38 billion. Regardless of which estimate turns out to be true, there will be significant cuts to spending made possible by large budget surpluses in recent years.

Up first are early actions to reduce funds appropriated in the FY 2023-24 State Budget. The Governor has proposed clawing back a total of \$392 million in Coastal Resilience Programs which could fund the Shoreline Project, \$50 million in Dam Safety grants, and \$174.4 million from recycled water. Staff has been meeting with our delegation members and key legislative staff urging them to

AB 2409 (Papan) Permitting Transparency for Water, Flood, Energy, and Restoration Projects

AB 2409, Valley Water's bill proposal now sponsored by the California Municipal Utilities Association, was referred to the Assembly Water, Parks, and Wildlife Committee on March 21. The bill will be scheduled for a hearing on or before April 26 and is well positioned for passage because the bill author, Assembly member Diane Papan (D-San Mateo), is chair of the Committee. Due to the bill's state cost, it must pass the Assembly Appropriations Committee on or before May 17, before going to the Assembly Floor and on to the Senate.

AB 2409, would require the Governor's Office of Planning and Research to create a dashboard website to increase transparency in state environmental permitting for public infrastructure projects, including water supply, flood risk reduction, energy reliability, and environment protection or enhancement projects with an estimated cost of \$100 million or more.

FEDERAL ADVOCACY EFFORTS

Staff Prepares for April Advocacy Trip to Washington, DC

On April 15-17, Chair Hsueh will lead a trip to Washington, DC, with senior staff to advocate for Valley Water funding and policy priorities. The Valley Water delegation will meet with key agency officials, Members of Congress, and congressional committee staff. The Office of Government Relations coordinates these visits to ensure that Valley Water is in regular communication with our federal representatives, providing project updates and working to advance policy priorities on behalf of Santa Clara County residents. This trip will focus on exploring funding opportunities for Valley Water's flood protection and water supply projects, such as the Anderson Dam Seismic Retrofit Project, South San Francisco Bay Shoreline Project, and the Purified Water Program. As we have seen large cost increases on infrastructure projects nationwide, it is important that we advocate for federal (and state) funding to help keep local costs to tax and water rate payers as low as possible.

Consideration of a Climate Resilience Bond

The Legislature continues to consider a potential climate resilience bond for the November ballot. Recent meetings with Valley Water's legislative delegation indicate there are three potential bonds competing for the available funding capacity of the state, which include climate resilience, housing, and education. Assembly Speaker Robert Rivas recently indicated that the state's capacity for all bond priorities is somewhere around \$15-\$16 billion. How much of that amount could be allocated to a Climate Resilience Bond versus potential housing and education bonds remains a key question for negotiation. Observers expect the Legislature to address the early budget actions, then the budget at large, before moving on to the bonds sometime in May or June. Valley Water staff will continue to advocate for our top priorities of dam safety, State Flood Control Subventions, urban flood protection, sea level rise, and recycled water.
