WHEREAS, the Parties desire to extend the term of the Agreement to allow Consultant to continue providing On-Call Planning and Design Services for Water Resources and Stewardship Support Services; and

NOW, THEREFORE, in consideration of the mutual promises and agreements stated herein and notwithstanding anything to the contrary stated in the Agreement and Amendment No. 1 Valley Water and Consultant hereby agree to amend the Agreement as follows:

- 1. Attachment Two to Schedule OC, Schedule of Completion, subsection 2 is amended to state as follows:
 - "2. This Agreement expires on December 31, 2025 unless, prior to its expiration, its term is modified by a written amendment hereto signed by both Parties. The additional option to increase the Agreement total Not-to-Exceed amount from \$1,000,000 to \$1,500,000 remains and may be exercised at the sole discretion of the District. The exercise of this option must be in the form of a written amendment signed by both Parties."
- 2. All other terms and conditions of the Agreement A4306A, and Amendment No. 1 not otherwise amended as stated herein remain in full force and effect.
