FEDERAL ADVOCACY EFFORTS

Staff Advocates with Congress to Expand Access to WIFIA Loans

As the federal government pauses or cancels grant awards, Valley Water is advocating for expanded access to financing programs like the Water Infrastructure Finance and Innovation Act (WIFIA) Program and the Corps Water Infrastructure Financing Program (CWIFP). Staff has met with several congressional committees in June to discuss why it is important for water agencies with congressionally authorized projects to use WIFIA and CWIFP to help finance costly and critical water infrastructure projects. Current law prohibits local project sponsors like Valley Water from using these programs to finance the local share of Army Corps-partnered projects such as the South San Francisco Bay Shoreline Project or the Upper Guadalupe River Project. Staff is working to advance legislation that would change these rules, expanding access to federal financing and reducing the burden on local taxpayers.

STATE ADVOCACY EFFORTS

Legislators Reject Audit for Delta Conveyance Project

A proposed audit of the Delta Conveyance Project did not pass the Joint Legislative Audit Committee after a coalition of organizations opposing it highlighted the existing robust transparency, public participation, and oversight requirements covering the project. Valley Water joined the California Department of Water Resources, Metropolitan Water District of Southern California, the State Water Contractors, and a coalition of water agencies and community organizations to testify against the requested audit. State Senators Josh Becker (D-Menlo Park) and Dave Cortese (D-San Jose) were among those who refused to vote for the unnecessary, duplicative, and costly request.
