Subject: City of Cupertino Review of SCVWD's Draft Capital Improvement Program (CIP), FY 2018-2022

Dear Mr. Nguyen:

City of Cupertino staff met with SCVWD staff last week to review proposed District CIP projects that have local and regional significance to the City. SCVWD staff were helpful in answering questions about the proposed CIP.

The Draft CIP has numerous projects with regional and local significance to the City of Cupertino. There are numerous projects that will repair, rehabilitate, replace or improve District infrastructure that provides high quality and reliable water supply to the City of Cupertino. We are pleased to see the District take a long-term view with respect to safeguarding its infrastructure from earthquake activity. Locally, there is a project on Permanente Creek to reduce potential flooding hazards; a multi-port outlet at Stevens Creek Reservoir to support a healthy steelhead trout population; and the new pipeline terminating near the new Apple Campus to supply recycled water.

Overall, the above mentioned projects will assist Cupertino in implementing its General Plan policies by:

- 1) Providing sufficient and reliable public infrastructure and services to the City;
- 2) Preparing for natural disasters, such as flooding and earthquakes;
- 3) Enhancing the natural qualities of Stevens Creek; and
- 4) Providing for a more sustainable City through the reuse of water resources.

We therefore find the Draft SCVWD CIP to be in conformance with the City of Cupertino General Plan.


At this time, the City of Cupertino would like to request that SCVWD look into further projects to stabilize Regnart Creek between Bubb Road and Highway 85. Due to the storm events the City experienced this winter, there was considerable scouring and erosion of the

banks along this section of creek. In one location, between the cul-de-sac ends of Orogrande Place and Wallin Ct, the bank adjacent to a pedestrian trail was eroded substantially enough that the City was required to restrict use of the trail. The City would like to see the bank stabilized so that the trail can be reopened to pedestrians.

In addition to the comments above, the City of Cupertino is interested in opening a pedestrian and bicycle trail along the Junipero Serra Channel, adjacent to Highway 280. The City's Public Works Department looks forward to working with the District to facilitate these trail improvements.

Dear Ngoc Nguyen:

Thank you for the opportunity to review the Santa Clara Valley Water District’s Capital Improvement Program for Fiscal Years 2018-2022. Staff focused on the Water Supply, Flood Protection, and Water Resources Stewardship components of the program. In response to your request for a determination of consistency with applicable local general plans, the Santa Clara County Department of Planning and Development is pleased to provide your agency with this correspondence.

The Santa Clara County General Plan provides broad goals, strategies, and policies concerning the importance of assuring a reliable, adequate long term water supply for the county, as well as ensuring water quality and stewardship of environmental resources. The Water District’s capital improvement program and priorities in no way conflict with those broad goals, strategies, and policies of the plan, as set forth in the Resource Conservation Chapter of the General Plan, Water Supply Resources Section, pp. H-5 – H-11, and the Water Quality & Watershed Management Section, pp. H-11 - H 19. Program components related to flood protection also reinforce and are consistent with the broad strategies and policies of the Natural Hazards Section related to flood hazards, pp. I-34 – I-40, of the General Plan. The emphasis on water supply-related investments appears appropriate in light of the District’s critical role in meeting demand as the state and region continue to cope with and address climate change induced variability in water resources.

The system infrastructure, dam maintenance/retrofit, and operational improvements as outlined in the Capital Improvement Program also further the goals and policies of the County’s General Plan.

Consequently, staff finds the CIP to be consistent with the County's General Plan in this regard. Please do not hesitate to inquire if you have additional questions or need of further information.

The Midpeninsula Regional Open Space District (Midpen) received your email request and the mailed CD containing the SCVWD FY2018-22 Five-Year Capital Improvement Program. We appreciate the opportunity to review the SCVWD's proposed Five-Year CIP. In our review of the CIP, it is our understanding that this planning document is to inform the public and other local agencies on projects that the SCVWD is proposing to work on and recommend funding in FY2018 and etc.

Midpen is already working closely with the SCVWD on projects, including but not limited to the establishment of the weather repeater equipment on the radar tower at Mt Umunhum Summit at Sierra Azul Open Space Preserve, the Permanente Creek Flood detention basin at Rancho San Antonio County Park, and other projects. In addition, our Natural Resources Department staff have been attending the South Bay Salt Ponds Restoration Project meetings.
