Valley Water invites you to a public hearing (Public Hearing) to be held Tuesday, April 22, 2025, at 1:00 p.m. regarding the Pipeline Maintenance Program (PMP or Project). The proposed work is described in the Engineer's Report for the PMP. The Engineer's Report and PMP Final Program Environmental Impact Report (PEIR) will be available for public review at [www.valleywater.org](http://www.valleywater.org) and will be available at the meeting.

The proposed PMP is an update to the 2007 Pipeline Maintenance Program (2007 PMP) and continuation of 10-YR Pipeline Inspection & Rehabilitation Program. The first PMP approved by the Valley Water Board of Directors in 2007 has been successfully implemented through 10-YR Pipeline Inspection & Rehabilitation Program in the most efficient and environmentally sensitive manner. Although Valley Water has successfully implemented the 2007 PMP, various circumstances and factors have evolved since that time, including field procedures and environmental and regulatory conditions. Thus, 2007 PMP requires an update to reflect current conditions. The updated PMP and PEIR brings Valley Water's documentation of pipeline inspection and rehabilitation practices up to date. The work under the updated PMP covers inspection, maintenance, and rehabilitation and/or repair of all existing conveyance systems for raw, treated, and recycled water that are owned and/or operated by Valley Water. The approval of the PMP will help ensure the long-term reliable operation of Valley Water's infrastructure and protect the public from risk associated with pipeline breaks.

At the time and place fixed for the Public Hearing, the Board of Directors will receive comments on the Engineer's Report and Final PEIR for the Project and will consider Final PEIR certification in accordance with the California Environmental Quality Act (CEQA). After these steps and after considering the comments on the Engineer's Report and Final PEIR, the Board will then decide whether to proceed with the Project or an alternative.

This meeting is being held in accordance with the Brown Act. The Public Hearing will be held during a board meeting and is accessible for public in-person participation at the time, date, and location shown above, and by public virtual participation at the Zoom link above.
