**Reasons Why Project is Exempt:** The Project qualifies for a Categorical Exemption under California Environmental Quality Act (CEQA) Guidelines §15301 and §15302:

*Class 1 (Existing Facilities) consists of the operation, repair, maintenance, permitting, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of existing or former use. Class 1 includes minor additions to existing structures and infrastructure.*

*Class 2 (Replacement or Reconstruction) consists of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity.*

None of the applicable exceptions noted under the CEQA Guidelines §15300.2 exist.

**Description of Project:**

The proposed Project would improve site security at five Valley Water facilities by replacing and improving existing chain link security fencing. All staging areas would be located on paved or previously disturbed gravel and dirt areas at each site. Best Management Practices (BMPs) have been incorporated into the Project. Work at each site would be completed in approximately one month and

would occur during construction work hours allowed by the local municipal code. The Project involves the replacement of existing fencing along the same alignments as the fencing to be replaced, with minor additions. The new fencing would have essentially the same purpose and capacity as the existing fencing with only negligible expansion of use.
