Dear Kerrie Romanow,

Pursuant to Section 8.3 of the Ground Lease and Property Use Agreement ("Lease Agreement") between the Santa Clara Valley Water District (Valley Water) and the City of San Jose, dated March 2, 2010 for the Silicon Valley Advanced Water Purification Center (SVAWPC), Valley Water is submitting the Final Plans and Specifications for a new storage building at the SVAWPC.

On May 15, 2018 Valley Water received an email that you approved of the project. On April 9, 2019 a 60% Design Submittal was sent to your office. On March 24, 2021 a 100% Design Submittal was sent to you via email. We have included the past communication with your office as an attachment for your reference. On November 23, 2021, we received plan check approval from the City of San Jose Public Works department and are ready to advertise the project for construction in January 2022.

Per the terms of the Lease Agreement, Valley Water is required to obtain prior written approval of the plans and specifications from the City of San Jose Director of Environmental Services before construction begins.
