FEDERAL ADVOCACY EFFORTS

Shoreline Project Tour for Rep. Ro Khanna's Staff

On October 18, staff coordinated a tour of the Shoreline Project (Phase 1) for 15 of Rep. Ro Khanna's staff. Staff educated the attendees about the importance of flood protection, environmental justice, planning for sea level rise adaptation, and engineering with nature. Staff also provided a brief history of the disadvantaged community of Alviso, along with the multi-purpose benefits of the Shoreline Project. After viewing Alviso Marina County Park, staff brought the attendees to Don Edwards San Francisco Bay National Wildlife Refuge Environmental Education Center where they viewed the project from an elevated level in the "Crow's Nest" and learned about Ohlone land, traditional ecological knowledge, as well as protecting wildlife and endangered species. The attendees were interested and engaged throughout the duration of the tour and expressed continued support and advocacy for the project.

Anderson Dam Tour for Rep. Jimmy Panetta

On October 28, Chair Pro Tem Varela hosted Rep. Jimmy Panetta on a tour of the Anderson Dam Seismic Retrofit Project. Chair Pro Tem Varela provided welcoming remarks and staff shared how critical the project is to our communities and our regional water supply for generations to come. After the presentation, staff led Rep. Panetta on a walking tour of the site, which provided a clear view of the construction work, and

reiterated the need for his continued support of the project through the "Tiger Team" meetings at the federal level, to help ensure the project keeps making forward progress.

STATE ADVOCACY EFFORTS

Assemblymember Robert Rivas Elected Speaker-Designee

On November 10, the State Assembly's Democratic Caucus convened to discuss who will become the next Speaker of the State Assembly. The Democratic Caucus voted to name Assemblymember Robert Rivas (D-Hollister) as Speaker-Designee with a transition from the current Speaker, Anthony Rendon (D-Lakewood), set for June 30, 2023. A letter of congratulations was sent to Assemblymember Rivas on behalf of the Valley Water Board by Chair Pro Tem John L. Varela.

Assemblymember Rivas has been a tireless advocate for Valley Water's priorities and a great champion for the region. Mr. Rivas authored two bills to facilitate the Anderson Dam Seismic Retrofit Project, including AB 271 which was enacted in 2021. He led the effort in 2022 to establish a state-funded dam safety grant program, securing a promise from the Administration and legislative leaders to appropriate \$100 million for dam safety in FY 2023-24.

The November 10 Democratic Caucus vote is a precursor to an official selection of the Speaker and Speaker-Designee in an organizational meeting of the Legislature on December 5, 2022.

The tour featured visits to Anderson Dam, Alamitos Groundwater Recharge Ponds, the Upper Guadalupe River Flood Protection and South San Francisco Shoreline Projects, and SVAWPC.
