Under no conditions will the total compensation to the Client exceed this fixed fee payment amount without prior written approval in the form of an amendment to this Agreement executed by the Client."
- 2. All other terms and conditions of Agreement A4603X, and Amendment No. 1 not otherwise amended as stated herein remain in full force and effect.
