Project Description:

The Cleanup and Surveillance Project was to achieve a trash-free Coyote Creek between Tully Road and Hellyer Park in San Jose by engaging community volunteers in the removal of trash along the banks and dry bed of the creek to reduce pollution impacts on water quality and fishery resources. The project progressed towards this vision through coordinating and organizing cleanups in conjunction with the Homeless Encampment Dismantlement Program.

The Education and Outreach Project was to (1) reach out to neighborhood and civic groups trail users and businesses to educate them about the potential for restoring Coyote Creek to a trash-free condition and (2) enlist their participation in creek cleanups to create a trash-free Coyote Creek.

Collectively, these projects accomplished the following:

By the numbers:

- a. Removed 81,800 pounds of trash through 14 cleanups accomplished by 1296 volunteers
- b. Hosted a Day-long Coyote Creek Howl conference attended by 150 people at San Jose State University
- c. Produced 9 informative brochures on topics such as Birds, Plants, Geology of Coyote Creek
- d. Provided 32 Presentations to community organizations
- e. Provided 14 community events presentations

Additional benefits:

- a. Integrated into the Homeless Encampment Dismantlement Program, i.e. providing volunteer trash removal to complement and support the encampment removals
- b. Coordinated support from San Jose Environmental Services Division (trash supplies and pickup) and Parks Department (Ranger support for volunteer safety)
- c. Coordinated cleanups with Hellyer Park (County Park system)
- d. Developed and refined methods for conducting efficient and safe cleanups
