Project Title: Upper Llagas Creek Flood Protection Project

Project Location: Southern Santa Clara County in the communities of Morgan Hill and San Martin. The Project includes portions of Llagas Creek, West Little Llagas Creek and East Little Llagas Creek between Buena Vista Avenue in the south to Llagas Road in Morgan Hill to the north, and west to Lake Silveira.


Project Description: The Project will provide 1-percent flood protection for West Little Llagas Creek in Morgan Hill, 10-percent flood protection on East Little Llagas Creek, and no induced flooding along Llagas Creek through the project limits. Work will include channel widening and deepening, a high-flow bypass tunnel under Nob Hill in Morgan Hill, maintenance roads, culvert modifications, aquatic habitat enhancements, the removal or relocation of utilities and structures, creation of wetland and riparian habitat at Lake Silveira, and acquisition of property needed to complete the project.

This is to advise that the Santa Clara Valley Water District has approved the above described project on June 10, 2014, and has made the following determinations regarding the above described project:
