**RE: July 25, 2017 Item 5.1, Proposition 1 funding application for the Pacheco Reservoir Expansion Project**

Dear Chair Varela and Members of the Board,

From its inception the Sierra Club has considered the protection of the natural environment to be a major policy priority. In that vein, we request to be involved in stakeholder outreach for the Pacheco Reservoir Replacement Project.

The Sierra Club is always concerned when new on-stream water impoundments are proposed in California. In addition, we are disappointed that this project is being pushed forward in such an unusual manner – applying for funding and purchasing land before feasibility studies have been completed. Furthermore, we are disappointed there has been no outreach to environmental stakeholders prior to this funding application.

There are many concerns that could impact the feasibility of this project.

- Environmental concerns include impact on species and habitat and water quality issues when Delta water is stored along this local watershed that ultimately flows to the Monterey Bay.
- It seems important to complete a comprehensive cost vs. benefit analysis before moving forward with implementation phase activities.
- Alternatives need to be considered, including the alternative scenarios in the Water Supply Master Plan. In particular, we think that developing Coyote Valley for groundwater storage would be more cost-effective, provide more environmental benefits, and have fewer environmental impacts than this dam project.
- This project should be evaluated through the lens of the One Water Plan, the District's most innovative planning effort, which is currently underway.

For these reasons, we think the District should return to a more standard approach for large new projects, including robust stakeholder involvement. We plan to be involved in this reservoir replacement project, and we would prefer to work with the District in the spirit of dialog.
