SMP Permit Status

The Stream Maintenance Program (SMP) runs from June 15 – October 15. The District submitted projects in two separate Notices of Proposed Work (NPW1 and NPW2). As reported earlier, all projects in the NPW1 were approved, except for six which will be resubmitted next year. We received approval from the San Francisco RWQCB late on August 16 for all but one of the proposed projects in NPW2, which clears most of the season's work.

We are continuing discussions with the Army Corps of Engineers and Fish and Wildlife Services on a handful of remaining NPW2 projects; however, we have over 400 approved projects lined up for the remainder of the work season.




Randol Creek, downstream of Bret Harte Drive: Before and After




