Dear Chair Varela, Vice Chair Santos, and Santa Clara Valley Water District Directors,

We are writing you to urge your aye vote on WaterFix in order to help secure our water supplies now and well into the future.

California is the sixth largest economy in the world, and Silicon Valley is a primary driver of our state's job creation and growth. Yet our success, the envy of much of the world, is at risk unless we move to protect our water supply. As business and civic leaders in the South Bay, we cannot stress enough the need to secure safe, clean, affordable drinking water for the health and economic well being of our region. The Silicon Valley Leadership Group supports WaterFix and we respectfully request that you do so as well.

As you know, California WaterFix is the plan to update aging infrastructure that brings clean, reliable water to our communities from the Sierra Nevada Mountains through the Sacramento San Joaquin Delta. Nearly half of the water that serves 2 million people here in the region, including 200,000 daily commuters, comes from the Delta, and a quarter of that is used for groundwater recharge. This high quality water is also used to improve the quality of other local and imported water supplies, increasing the amount of safe drinking water available for communities throughout the region.

This fresh water is at risk of contamination from salt water due to rising sea levels associated with climate change, as well as an earthquake, which would easily liquefy the existing earthen levees in the Detla. WaterFix provides a solution – in fact, the only viable and detailed solution – to address these risks and shore up the water supply we, and most Californians, rely on.

This summer resulted in significant momentum for the project, with positive opinions from the federal government and project approval by the state. Now, after a decade of detailed analysis, planning and environmental review, and with over 70 percent of county residents supporting the project, it is up to you to commit to WaterFix.

The Zone 7 Water District in Alameda recently voted to move forward and support the project, as did Metropolitan Water District and various other water agencies. Unfortunately, the large agricultural Westlands Water District opted out of the current financing plan. But that doesn't mean we shouldn't move forward locally. Ultimately, Santa Clara County Water District should vote to approve a "userbased" financing plan that ensures we only pay for the water we get. We believe that is still possible despite the Westlands decision.

We applaud the Water District for its work to double down on water recycling and conservation. But even this, we believe, will not be sufficient to meet the region's future needs without WaterFix to help secure a baseline level of high quality water.

While others may push back on the plan, we urge you to focus on the fact that there is no other practicable, comprehensive and economically viable plan to supply the volume of water our region needs. While we support investing in local water supply projects, we believe the Delta will continue – for quite some time – to be an important source of water for our region.

As community leaders we are also very conscious of the fact that access to safe, affordable drinking water is a social justice issue. Respected Members of Valley Water Board;

I urge you, in the strongest language possible, to pursue WaterFix immediately. With the Winter rains of 2016 – 2017, we received advanced notice of what will come with future weather events in our region. The massive water issues plaguing our geographic area are too big to ignore, and your prompt action to pursue better water policy is increasingly important. The infrastructure is beyond aged...it is at crisis stage and must be addressed immediately. We cannot rely on ancient levee systems to protect our cities and towns any longer. Preventive maintenance is just a band-aid on a much larger problem for a system that was never designed to last this long. Failure to act now jeopardizes residents, and ultimately costs more in disaster relief than a carefully planned and well-executed system of replacement over time. In addition, water flows to Central Valley rivers, estuaries, and streams is vital to correct decades-old practices of water diversion and habitat destruction.
