For the considerations hereinafter specified, Contractor and Disirict agree as follows:

## ARTICLE I: Work to Be Done and Documents Forming the Contract

Contractor agrees to do all the work and furnish all materiais necessary to construct and complete, in accordance with the Specifications the following work:

For the performance of said work; provided, however, that the above mentioned sum is one determined by the Proposal of Contractor as based upon the estimated amount of work to be done, and should there be any variance between the estimated amount of work to be done and the actual amount of work performed, then the final payment pice shall be computed on the basis of the unit prices contained in the Proposal of Contractor.

## ARTICLE III: Completion of Contract

解 is hereby agreed that the work catled for under this Contract, in all its parts and requirements, shall be completed before the expiration of 135 calendar days from the First Chargeable Day of the Contract as stated on the Notice to Begin Work unless the time for completion is extended, as allowed by the Specifications.

## ARTICLE IN: Bonds Required

This Contract shall have no force or effect whatsoever unless and until Contracior delivers to District a Paynent Bond in the sum of Five Fhundired Thirty-Five Thousand Five Hundred Fifty-Three Dollars (\$535,553.00).

Nor shall such Contract be effective until Contractor also gives a good and sufficient bond in the sum of Fwe Hundred Thirty-Five Thousand Fwe Hundred Fifty-Three Dollars $(\$ 535,553.00)$ for the falthful performance of the work to be done under the terms of this Contract.

## ARTRCEE V: Certification by Contractor

Contractor hereby certifies as follows:
"I certify that I am aware of the provisions of Section 3700 of the Labor Code which requires every employer to be insured against liability for workers' compensation or to undertake self insurance in accordance with the provisions of that Code, and 1 will comply with such provisions before commencing the performance of the work of this Contract:"

## ARTICLE VI: Giff Policy Observance

Contractor hereby acknowledges that District policy prohibits the acceptance by District personnel of gitts of any kind from vendors or contractors. Contractor shall honor this policy by not sending or bringing gifits to the District.
