Under no conditions will the total compensation to the Consultant exceed this fixed fee payment amount without prior written approval in the form of an amendment to this Agreement executed by the District's Board of Directors ("Board"), or Chief Executive Officer as authorized by the Board."

3. In the Agreement, Attachment Two to Schedule A-GEN, Schedule of Completion Section 2, replace the paragraph in its entirety with the following:

"This Agreement expires **February 28, 2019** unless, prior to its expiration, its term is modified by a written amendment hereto, signed by both Parties. The District may extend the Agreement for two one-year periods upon written amendment executed by both Parties."

4. All other terms and conditions of Agreement A4055F, Amendment No.1, not amended as stated herein, remain in full force and effect.
