#### AMENDMENT NO. 1 TO AGREEMENT A3990R 2016 SAFE, CLEAN WATER PRIORITY B3 GRANT PROGRAM BETWEEN THE SANTA CLARA VALLEY WATER DISTRICT AND ACTERRA STEWARDSHIP

This Amendment No. 1 (Amendment), effective as of the date it is fully executed by the Parties, amends the terms and conditions of the 2016 Safe, Clean Water Priority B Grant Program Agreement A3990R (Agreement) dated June 14, 2016, between SANTA CLARA VALLEY WATER DISTRICT (District) and the Acterra Stewardship, a fiscally sponsored project of Acterra: Action for a Healthy Planet, a non-profit 501(c)(3) organization (Grantee). The Amendment No. 1 is entered into by the District, Grantee, and Grassroots Ecology, a non-profit corporation incorporated in the State of California, collectively the Parties.

#### **RECITALS**

**WHEREAS**, Grantee has been serving as Grassroots Ecology's fiscal sponsor for the purpose of Grassroots Ecology receiving grant funds under this Agreement;

**WHEREAS**, the Agreement provides for Grantee to receive a grant amount of up to \$93,617 from the 2016 Safe, Clean Water Priority B Grant Program for the Greening Urban Watersheds (Project); and

WHEREAS, Grantee has invoiced and received \$36,482 of the Project grant amount; and

**WHEREAS**, Grassroots Ecology no longer requires Grantee to serve as its fiscal sponsor because Grassroots Ecology is now a non-profit 501(c)(3) corporation; and

**WHEREAS**, Grantee now seeks to assign, transfer and convey this Agreement to Grassroots Ecology.

**NOW, THEREFORE**, in consideration of the mutual promises and agreements stated herein and notwithstanding anything to the contrary in the Agreement, the Parties hereby agree to amend the Agreement as follows:

- 1. Grantee does hereby assign, transfer and convey to Grassroots Ecology all right, title, interest and obligations of the Agreement (Assignment).
- Grassroots Ecology does hereby assume and accept all obligations and liabilities of Grantee related to the Agreement and agrees to be bound by all terms and conditions of the Agreement.
- 3. District does hereby consent to the Assignment.
- 4. Grassroots Ecology and Grantee recognize that the District is acting in reliance upon the Assignment and expects Grassroots Ecology to perform as the District would have expected Grantee to perform under this Agreement.

- 5. After the Assignment, Grassroots Ecology shall be recognized as the "Grantee" where that term is refered in the Agreement.
- 6. Grassroots Ecology shall provide the District with the insurance certificates and endorsements from its insurance broker(s) satisfying the Insurance Requirements contained in Appendix H.
- 7. Appendix G to the Agreement, Resolution, is deleted and replaced with the Grassroots Ecology's board resolution, attached to this Amendment No. 1.
- 8. Section 4. Miscellaneous Provisions. B. Notices, is deleted in its entirety and replaced with the following:
