#### Status of Unmanned Aerial Vehicle (UAV/Drones) pilot project proposal.

At the board meeting on December 19, 2017, the board directed the district to develop a pilot project for using Unmanned Aerial Vehicles (UAV/Drones) in land surveying and mapping activities. As presented to the board, part of the project development is to solicit public feedback on the proposed use of UAV/Drones in district work. The Land Surveying and Mapping Unit (LSMU) is leading the project development and working with Office of Communications to conduct outreach in the community.

The district is planning to place an advertisement in the San Jose Mercury News and the Metro Silicon Valley publications by August 10, 2018. The purpose of the advertisement is to solicit public feedback on the proposed pilot project to use UAV/Drones countywide for district work. The public feedback period will last for at least thirty (30) days before the district returns to the board with the pilot program proposal. LSMU anticipates presenting a proposal for the UAV/Drones pilot program to the board in November 2018.

### Pacheco Reservoir Tour Status R-18-0012

The district is currently working on the logistics associated with accessing the property at Pacheco Reservoir. The owner of the property, which contains the road by which the existing Pacheco Dam is accessed, has indicated that district does not have authority to access the site. As such, the district is working with the Pacheco Pass Water District to access the property utilizing their existing easement.

Once the issue of property access is resolved, the district will schedule a tour for all interested members of the board, as requested by Vice Chair LeZotte. In addition, the district is exploring the potential for future site tours for the public, including a virtual tour option, which will be necessary during the wet season when inclement weather makes touring onsite infeasible.
