California WaterFix Delta Conveyance Design and Construction Joint Powers Authority Board of Directors Meeting

On July 19, 2018, the Delta Conveyance Design and Construction Joint Powers Authority (DCA) Board of Directors met. The DCA Board ratified the actions taken at the May 17, 2018, DCA Board meeting. The DCA Board also adopted a total proposed budget for Fiscal Year 2018/2019 of \$133.57 million.

Other DCA Board actions included:

- Authorizing the Interim Executive Director to execute transition services with Hallmark Group
- Authorizing Interim Executive Director to begin the process of negotiating leasing office space for the authority staff
- Delegating contracting authority to the Executive Director for \$250,000 or less
- Adopting a thorough records retention policy

Bylaws will be brought forward at a future board meeting. Recruitment for the Executive Director is in process and an update on that action will be brought to the board at a future meeting.

California WaterFix Delta Conveyance Finance Authority Board of Directors Meeting

On July 19, 2018, the Delta Conveyance Finance Authority Board of Directors met for the first time. The Board identified its Chair - Randy Record from Metropolitan Water District, Vice Chair - Gary Kremen from Santa Clara Valley Water District, and Secretary - Jeff Davis from San Gorgonio Pass Water Agency.

The Board took the following actions:

- CEQA findings resolution approved
- Appointed Brian Thomas as Interim Executive Director
- Approved an agreement with Metropolitan Water District for treasurer/controller requirements

The Interim Executive Director gave a presentation on the Letter of Interest (LOI) for the Water Infrastructure Finance and Innovation Act (WIFIA) of 2014 federal credit program. The Board authorized the Interim Executive Director to submit the WIFIA LOI in time for the July 31, 2018, deadline.

The Board also authorized the Interim Executive Director to submit all documents necessary for the formation of the Authority.

Safe, Clean Water and Natural Flood Protection Project Completion: San Francisco Bay Bird Observatory completes the Establishing Forster's Tern Nesting Colonies for the South Bay Salt Pond Restoration Project Using Innovative Technologies Project

In June 2016, San Francisco Bay Bird Observatory (SFBBO) received a \$217,032 Safe, Clean Water and Natural Flood Protection D3 (Restore Wildlife Habitat) grant to deploy and maintain decoys and electronic call systems to help establish a healthy nesting population of at-risk Forster's terns in Alviso Pond A16 within the Don Edwards San Francisco Bay National Wildlife Refuge. The project began on November 1, 2016, and was completed on April 30, 2018. The overall total cost of the project was \$294,232.97.

During the project, SFBBO deployed 300 Forster's tern decoys and six electronic call systems on six islands in Pond A16 during the 2017 breeding season. Bird surveys were conducted between March and August 2017, to evaluate bird response and the results of the project suggest that implementation of decoys and electronic call systems was successful in attracting Forster's terns in

Alviso Pond A16.

Key Outcomes:

- 197% increase in the number of Forster's terns in the pond in May 2017, compared to similar results recorded in May of 2016
- More Forster's terns were observed around the island with decoys and electronic call systems compared to islands without them, an approximately 6:1 ratio
- Eight (8) Educational outreach activities were completed:
 - o development of a project website
 - o One (1) educational video
 - o Three (3) public presentations
 - o One (1) publication of popular article
 - o Two (2) visits with local elementary school students

SFBBO's final report on the completed project is included in the Board's August 24, 2018, Non-Agenda package.
