# AMENDMENT NO. 1 TO AGREEMENT A3860R 2015 SAFE, CLEAN WATER PRIORITY D3 GRANT PROGRAM BETWEEN THE SANTA CLARA VALLEY WATER DISTRICT AND THE COUNTY OF SANTA CLARA

This Amendment No. 1 (Amendment), effective as of the date it is fully executed by the Parties, amends the terms and conditions of the 2015 Safe, Clean Water Priority D Grant Program Agreement A3860R (Agreement) dated June 12, 2015, between SANTA CLARA VALLEY WATER DISTRICT, a special district operating under the laws of the state of California ("District" or "Grantor") and the COUNTY OF SANTA CLARA, a political subdivision of the state of California ("County" or "Grantee"). Collectively, the Grantor and Grantee are the "Parties" and each is a "Party" to this Amendment.

## **RECITALS**

WHEREAS, the Agreement provides for the Grantee to receive a grant amount of \$200,000.00 from the 2015 Safe, Clean Water Priority D Grant Program to construct multi-use trails adjacent to Calero Reservoir at Calero County Park, described in the Appendix A of the Agreement; and,

WHEREAS, the Grantee has not yet invoiced or received any of the Project Grant Amount; and,

WHEREAS, the initial term of Agreement expires on June 30, 2018, at which time the Project will not be completed; and,

WHEREAS, the Project has been delayed due to permitting and staffing challenges. The Grantee's Lake and Streambed Alteration Agreement (LSAA) permit restricted work in ephemeral drainages during the wet season from November 2016 to March 2017. Storm damage during winter 2016-2017 diverted already limited staff time to perform inspections and conduct repairs to recently constructed trails; and,

WHEREAS, the Grantee has the dedicated human and financial resources to advance the Project, and the Grantee and the District now seek to extend the term of the Agreement by an additional 12 months; and,

WHEREAS, the District seeks to update its contact information in the Agreement.

NOW, THEREFORE, in consideration of the mutual promises and agreements stated herein and notwithstanding anything to the contrary in the Agreement, Grantee and the District hereby agree to the foregoing and to amend the Agreement as follows:

1. Section 2. General Provisions. H. Agreement Term., Paragraph 1, is amended by replacing the current expiration date of "June 30, 2018", with "June 30, 2019".
