

BOARD OF DIRECTORS MEETING

MINUTES

SPECIAL JOINT MEETING WITH CONTRA COSTA WATER DISTRICT FRIDAY, MAY 3, 2019 10:00 AM

1. CALL TO ORDER:

A Special Joint Meeting of the Santa Clara Valley Water District (Valley Water) and Contra Costa Water District (CCWD) Boards of Directors was called to order in the Silicon Valley Advanced Water Purification Center, Visitors Center, at 4190 Zanker Road, San Jose, California, at 10:00 a.m.
