1. What do you feel are the top three issues young people in Santa Clara County are facing, particularly around water or environmental stewardship? If appointed, how will you connect these issues to your role on the Youth Commission?

I'm frustrated by the tendency of most environmental service opportunities to focus on the immediately observable. For instance, while projects such as river cleanups are beneficial, they underscore society's proclivity to tackle symptoms of environmental issues, rather than root causes. Not only must we ask "How many pounds of river trash can we pick up?", we must also consider, "Why is there so much trash in the first place?" The narrow scope of such projects provides volunteers with little background on environmental issues.

Personally, I have witnessed considerable water pollution that compromises our water supplies and endangers fragile ecosystems. The factors surrounding pollution are incredibly complex and even fascinating, representing an agglomeration of human land use, weather, and geography. With thousands of miles of leak-prone sewage pipes, tonnes of accumulating trash, and the threat of eutrophication from runoff, tackling this issue necessitates community engagement on an unprecedented scale.

Finally, the conflict between sustainable ideals and corporate interests represents a significant roadblock to environmentalist pursuits. Anti-environmentalists have bitterly held on to the status quo for decades, ranging from chemical companies that sued Rachel Carson in the 1960s, to coal lobbyists today who threaten to block a future of green energy. By dismissing environmental conservation in favor of monetary gain, this thinking will inevitably jeopardize the future of our planet. And with the huge political influence of these corporations, young, dissenting environmentalist voices are often suppressed.

I'll leverage my position on the Youth Commission to educate my community on environmental issues including these three. To accomplish this, I'll champion citizen science as a force to stimulate curiosity, generate new knowledge, and foster appreciation for science and nature. I'll serve as a voice for conservationists on these issues, all while developing a multifaceted perspective founded upon nearly a century of water conservation work.
