## **December 2019 Activities Update**





The Valley Water Board of Directors is joined by CEO Norma Camacho and representatives of the cities of Palo Alto and Mountain View for a toast to the water reuse agreement.

## Water Reuse Agreement

Staff coordinated a media event to commemorate Valley Water's Board of Directors approving the partnership with the cities of Palo Alto and Mountain View regarding efforts to expand recycled and advanced purified water in Santa Clara County. Staff prepared talking points for the event, which was emceed by CEO Norma Camacho. Director Gary Kremen gave remarks, along with Palo Alto City Council Member Tom DuBois and Mountain View Mayor Lisa Matichak. A joint press release with the cities of Palo Alto and Mountain View, which included quotes from Director Kremen, Palo Alto Mayor Eric Filseth and Mayor Matichak, was written by staff and posted on Facebook and Twitter. The press release resulted in several media inquiries, and staff coordinated press interviews before, during and after the event. Staff recorded a Facebook Live during the event and wrote and posted a blog to valleywaternews.org.

## Media, Communications and Social Media

Staff wrote and posted five stories on valleywaternews.org on the following subjects:

The flood awareness advertising campaign launched in December with ads running in print, radio and online digital media channels in four different languages: English, Spanish, Chinese and Vietnamese. Ads were also strategically placed on billboards and transit shelters in flood prone areas throughout the county. This year's theme is "Get Flood Ready" with three key messages: know your risk, prepare your home and get insured. Staff produced "Get Flood Ready" videos in English, Spanish, Chinese and Vietnamese and posted them to Valley Water's social media channels. The videos have been viewed 98,731 times. The annual floodplain mailer is scheduled to be delivered to homes and businesses in FEMA-designated flood zones in January.

Staff coordinated the production and distribution of the 2019 countywide mailer, which was sent to residences and businesses in Santa Clara County.

Staff also coordinated the production of the 2020 Valley Water calendar and fiscal year 2018-19 annual report, which is made available upon request to residents of Santa Clara County.

Valley Water was highlighted in the Imagine a Day Without Water summary memo from the Value of Water Campaign. Under the Social Media Highlights, Valley Water's video with Chair LeZotte was mentioned along with a photo of the post.

Valley Water participated in a joint news release with several Bay Area water agencies entitled "How Water Agencies Delivered Reliable Water Service During Power Shutoffs."

Staff responded to media inquiries on the following topics: stormrelated inquiries; rain and reservoir levels; Valley Water's response to a news story on U.S. Drought Monitor reporting California was completely drought free for first time since 2011; the importance of emergency preparedness; updates on reservoir levels, a timetable for the Anderson Dam Seismic Retrofit Project; and an update on the Upper Llagas Creek Flood Protection Project.

Staff prepared Nextdoor messages for board members on the following topics: Upper Llagas Creek Flood Protection Project at Lake Silveira construction update; Levee repairs complete at Uvas Creek; Early morning construction - Coyote Pumping Warehouse Project; Planting taking place at Rinconada Water Treatment Plant.
