### FEDERAL ADVOCACY EFFORTS

### **Congress Returns, Staff Explores All Opportunities to Advance Interests in Election Year**

Congress reconvened for the second year of its two-year session, picking up where it left off in December. All pending legislation remains active until the Congress adjourns at the end of 2020. While legislative activity is expected to slow substantially in preparation for the November elections, staff is aggressively exploring all potential legislative vehicles for advancing our projects and priorities. These include:



Water Resources Act

Several other water infrastructure bills are expected in the coming weeks, and staff is working with our Congressional delegation and committee staff to advance Valley Water interests in those bills as well.

Finally, staff is working with our Congressional delegation to advocate for funding under the U.S. Army Corps of Engineers' Fiscal Year 2020 work plan for the South San Francisco Bay Shoreline Project (Phase II, Economic Impact Areas 1-10) and the Upper Guadalupe River Flood Protection Project. The work plan is expected to be submitted to Congress in early February.

### **Valley Water and Regulators Meet with Congressional Delegation to Advance Anderson Project**

On December 4, 2019, Chair LeZotte led a delgation of senior Valley Water staff to Washington, D.C., to meet with all four members of the Santa Clara County Congressional delegation, high-level officials from federal regulatory agencies, and local stakeholders to discuss how all involved can work together to move the Anderson Dam Seismic Retrofit Project forward as expeditiously as possible. It was a productive session, with the principals from each agency agreeing to convene regularly to discuss progress and address any concerns. Completing this project as quickly and safely as possible is Valley Water's top priority, and there is wide agreement from others about the importance of public safety. Staff will continue to work closely with Members of Congress and the Administration to ensure that the project is moving along quickly and that any concerns or challenges are quickly elevated.

### **Legislature Back in Session**

On January 6, the Legislature reconvened for the second year of the 2019-2020 legislative session. Bills introduced in 2019 that fail to pass out of the first house by January 31 will die. Staff is closely watching 2-year bills, particularly those on which the Board has a position, for late amendments, hearings, or other actions that indicate the bill may be reconsidered. New bills for 2020 must be introduced by February 21, and staff is working on a Valley Water sponsored bill to expedite the Anderson Dam Seismic Retrofit Project, as well as working with our membership advocacy organizations on a host of bills to benefit the delivery of clean drinking water, environmental stewardship, and flood protection.

### **Governor Releases Proposed State Budget for FY 2020-21**

On January 10, Governor Gavin Newsom released his \$222.2 billion proposed state budget for fiscal year 2020-21. In addition to funding to address high-priority issues like fire danger, housing, homelessness, and the PG&E bankruptcy, the budget proposes \$12.48 billion in climate resilience funding over the next five years.

Under the plan, the implementation of the Governor's recently released Climate Resilience Portfolio would be paid in part by a \$4.75 billion climate resilience bond proposed for the November 2020 ballot. The bond would borrow \$2.9 billion for drinking water, flood protection, and drought funding, including \$1 billion for water resilience projects (recycled water, efficiency, storage, and conveyance), \$340 million for flood subventions, \$270 million for multi-benefit flood risk reduction, and \$140 million for enhanced stream flow and fish passage projects. The bond also would include \$500 million to the State Coastal Conservancy to address sea level rise.

Also included in the budget is a program to modernize and improve biodiversity protection through regulatory efficiencies, an issue for which Valley Water has advocated strongly for years through sponsored legislation and other advocacy. The Governor's proposal calls for "cutting green tape" with annual appropriation of \$4 million to the Department of Fish and Wildlife to improve permitting efficiency through early consultation, permit workshops, and existing permitting program options. The Office of Government Relations will continue to advocate for funding and other Valley Water interests through the budget and bond processes.

#### Water Resilience Portfolio

On January 3, the Newsom Administration released their draft Water Resilience Portfolio (Portfolio) and requested public comment by February 7, 2020. The Portfolio is the result of an April 2019 executive order and incorporates recommendations from hundreds of entities, including Valley Water. The document consists of more than one hundred goals and is intended to chart the state's continuing response to more extreme droughts and floods, rising temperatures, depleted groundwater basins, aging infrastructure, and other challenges intensified by climate change.

Staff throughout Valley Water participated in several stakeholder groups to provide input, which ultimately was included in a letter the Board sent to the Governor to advocate for Valley Water's interests. The resulting draft Portfolio aligns with many of the Board's and Valley Water's priorities.

# South San Francisco Bay Shoreline Project - State Flood Control Subventions Authorization

On December 16, 2019, the Department of Water Resources accepted the State Cost Share Report drafted by Valley Water staff and accepted the calculations of the non-federal sponsors' costs for the South San Francisco Bay Shoreline Project, Phase I. Once the authorization process is completed, the Shoreline Project will be eligible to receive state reimbursements totaling over \$9 million. The authorization is the next step as required by the Valley Watersponsored state bill Senate Bill 881 (Wieckowski) which was signed into law in 2018, adding the Shoreline Project to the list of state projects in line for State Subventions Funding. The State's Cost Share Report will now be made available on January 15 for a 45-day public comment period.
