This Amendment No. 6 (Amendment), effective as of the date it is fully executed by the Parties, amends the terms and conditions of the Standard Consultant Agreement No. A3741G (Agreement) dated July 2, 2014 as amended by Amendment No.1 dated February 9, 2016, Amendment No. 2, dated May 22, 2017, Amendment No. 3 dated June 12, 2018, Amendment No. 4 dated November 19, 2018, and Amendment No. 5 dated January 7, 2019 between SANTA CLARA VALLEY WATER DISTRICT (District) and ERROL L. MONTGOMERY & ASSOCIATES, INC. (MONTGOMERY & ASSOCIATES; Consultant), collectively, the Parties.

# RECITALS

**WHEREAS**, Consultant has been performing professional services relating to a Groundwater Charge Zone Study; and

**WHEREAS**, the project budget is adequate to complete work under Tasks 1 through 5 and supplemental services under Task 6 previously authorized by Task Order, but no budget would be available to support unanticipated work; and

**WHEREAS**, additional work may be needed to support Valley Water Board of Directors consideration of proposed groundwater zones and/or zone implementation; and

**WHEREAS**, unanticipated work related to zone consideration and/or implementation will likely need to be expedited, requiring funding for related tasks to be available; and

**WHEREAS**, the Parties desire to increase the not-to-exceed amount allocated to Task 6 Supplemental Services to cover any unanticipated work.

**NOW, THEREFORE,** in consideration of the mutual promises and agreements stated herein and notwithstanding any provision to the contrary stated in the Agreement, Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, or Amendment No. 5, District and Consultant hereby agree to amend the Agreement as follows:

1. In the Revised Appendix Two, Fees and Payments, Sections II Total Authorized Funding & III Cost Breakdown, to state as follows:

#### "II. TOTAL AUTHORIZED FUNDING. (REVISED)

Total payment for Services performed, as described in the Schedule(s) will not exceed a total amount of \$613,547 (Not-to-Exceed Fees or NTE). Consultant guarantees that it will complete the Scope of Services within this \$613,547 NTE. Under no conditions will the total compensation to the Consultant exceed this fixed fee payment amount without prior written approval in the form of an amendment to this Agreement executed by the District's Board of Directors (Board), or Chief Executive Officer, or designee, as authorized by the Board.
