PUBLIC ARTS AND SIGNAGE

- Continued to facilitate the Youth Commission's work on the Adopt-A-Bench Art project to develop artwork for seven pilot benches. The Commissioners reviewed the draft artwork concepts on Feb. 19 and are working with the art advisor to finalize the artwork to present to the Board on Mar. 10.
- Continued working with the Silicon Valley Bicycle Coalition to develop the full signage inventory scavenger hunt campaign, expected to run from Apr. 1 to Jun. 30.

SAFE, CLEAN WATER GRANTS AND PARTNERSHIPS

On Feb. 11, the Board approved the FY20 grant funding for five B3: Pollution Prevention projects and two D3: Restore Wildlife Habitat projects. The Board also approved a pilot mini-grant program for A2: Water Conservation and revision to the grant allocation matrix for D3: Restore Wildlife Habitat. Staff is working with the awardees to execute grant agreements, and is developing outreach for the pilot Water Conservation mini-grant program.

EDUCATION OUTREACH

During February, Education Outreach presented to 925 students from 33 classrooms in 9 Santa Clara County Schools.

- During February, Education Outreach staff led 3 Outdoor Classroom tours. One tour at the Alamitos Outdoor Classroom for Girl Scouts preparing for their "Wonders Of Water" badge, and two school tours at the Coyote Valley Outdoor Classroom and the Alamitos Outdoor Classroom. Students focused on watershed stewardship, the water cycle, pollution reduction and learning about groundwater and where our water comes from, EO staff also supported the Job Shadow Day event by providing three tours of the Water Quality Lab for the high school students that attended.
- On Feb. 18, Education Outreach presented the "Elmo and Grover In The Park" puppet show to 100 attendees at the Palo Alto Children's Library and also discussed how to be ready for floods and other emergencies by preparing emergency supplies.
- On Saturday, Feb. 29, Education Outreach staff supported the San Jose State University's 20th "Science Extravaganza" and presented a hands-on watershed mapping activity to ~100 5th - 7th grade students from local schools. The focus of the event is to promote STEM careers.

Topics of discussion include, Valley Water's Floodplain Mailer (FPM); Communication's flood awareness outreach efforts; branding our countywide flood awareness outreach efforts (e.g. disseminating same materials, "Get Flood Ready Emergency Supply List" tote bags, FPM, National Flood Insurance Program and Ready.gov publications); Valley Water's role in SC County's CRS Program; and began discussions on updating the 2015 Multi-Jurisdictional Program for Public Information (PPI) to develop the 2020 PPI.
