Imagine a Day Without Water

The sixth annual Imagine a Day Without Water occurred on October 21 and staff highlighted it by producing three videos in advance of the Value of Water national campaign effort. Chair Hsueh delivered a message to bring awareness about the water infrastructure and personnel needed to provide safe, clean water to Santa Clara County. All three videos were shared on social media platforms prior to the event.

Preparation for the 2020 Flood Awareness Campaign

Staff worked on finalizing this year's flood awareness campaign, which is composed of multilingual flood preparedness messaging for Santa Clara County residents. It focuses on informing property owners and tenants of businesses and homes located in prone areas of flood preparedness. The 2020 Flood Awareness Campaign was presented to our partner cities during the recent Winter Preparedness Workshop on October 28. The campaign will begin in November 2020.

During October, staff continued to produce and lead the biweekly town halls to provide staff with updates and bring awareness of resources, engagement opportunities, and other relevant items. In addition, staff supported the Emergency Operations Center activation with a variety of communications and outreach efforts.

response to a media advisory on the NAACP Sea Level Rise and Flood Management Response Certification training; La Oferta published the media advisory on Valley Water's preparation for PG&E's Public Safety Power Shutoffs (PSPS); KTVU reporter requested information on the impact of wildfires on Valley Water's treatment process; San Jose Spotlight interviewed Deputy Operating Officer Rechelle Blank and Engineering Unit Manager Sunshine Julian about the Almaden Lake Improvement Project; KQED submitted a media inquiry regarding the large release of recycled water into a storm drain that leads to San Tomas Aquino Creek; and ABC7 News requested records of the boundaries of the 1985 Lexington Reservoir fire for an insurance rates story.

Staff prepared Nextdoor messages for board members on the following topics: Learn how to apply for a Valley Water Safe, Clean Water grant; Become a water ambassador – apply today to our new Water 101 Academy; Have a question for Valley Water? Ask the CEO; Make sure your voice is heard and vote; Sea level rise & flood management certification training; Measure S: Renewal of Safe, Clean Water Program funding; and all aboard, new water infrastructure virtual bus tour series.
