Chair Hsueh and Board Members,

The Sierra Club has been working for several years to promote sustainable approaches to future water supply in the State of California. We strongly believe our state and local agencies need to prioritize projects and approaches that are least damaging to the environment, have the least impact on disadvantaged communities, are most cost effective, and are most helpful in mitigating our climate emergency.

We ask that you keep the following points in mind as you discuss and decide which projects in Valley Water's water supply scenario you will and will not continue to pursue given the significant decrease in projected water demands in Santa Clara County.

1. Valley Water needs to remove projects from the water supply portfolio that will result in future over-investment and stranded assets. It is important to avoid unnecessary costs and water rate increases that could burden future generations.
2. Large construction projects are most damaging to the environment, indigenous land and culture, and environmental justice communities. Not only do these projects damage valuable habitat and natural/working lands at the construction site, they also require large amounts of materials to be extracted elsewhere and transported to the project location, resulting in increased emissions that contribute to climate change.
3. It is increasingly important to evaluate environmental and social justice impacts when evaluating projects to include in the Water Supply Master Plan portfolio going forward. The potential for cost escalation must be part of this evaluation to avoid substantial water rate increases in the future. Large construction projects that require extensive land disturbance and are still early in the design phase have high potential for increasing costs and rate impacts going forward. These projects include the Delta Conveyance, Sites Reservoir, and Pacheco Reservoir.
4. Reducing reliance on the Delta is an important statewide policy and re-evaluation of the water supply project portfolio provides Valley Water with an extraordinary opportunity to adhere to and further this policy by prioritizing local and regional water supply.

Moreover, we believe the following recommendations should and can be implemented immediately to allow Valley Water to meet water supply demand in a sustainable, cost-effective, and equitable manner:

1. **Reduce participation in the Delta Conveyance project.** To reduce investment risks and future extreme rate increases, remove the CVP portion of Delta Conveyance Project from consideration as part of the investment scenario.
2. **Prioritize water conservation, recycled water, and stormwater capture.** These supplies are least damaging to the environment and best for mitigating climate change and providing resilience in the face of climate change impacts on water supply. Consider including distributed approaches such as onsite and district scale recycling and stormwater retention. We note that the Monitoring and Assessment evaluation presented on October 27 indicated that future water demand can be met using these approaches.
3. **Rethink the water supply investment scenario through the lens of environmental and social justice.** It appears that the WEAP analysis does not consider either environmental justice or climate change impacts (GHG emissions) to evaluate scenarios. We encourage Valley Water to evaluate these impacts and use this information to prioritize alternatives that limit water rate increases, impacts on indigenous culture, and impacts on climate change and resource extraction moving forward.

We look forward to working with you.

Dear Board of Directors:

On behalf of Sierra Club California and our more than 500,000 members and supporters statewide, **we write to urge you not to fund this next phase of the Delta Conveyance (aka the Delta Tunnel) project.**

Our members, supporters, and staff are well-versed in California's efforts to develop and implement smart, equitable water policies that support our communities and economy while also protecting the state's precious environment. And with this knowledge and experience, we routinely participate in the necessary public processes and forums that can yield resilient and sustainable water management policies for all Californians.

The Delta Tunnel project is estimated to cost \$16 billion, before inflation, and up to \$40 billion. Ratepayers will see higher water bills and property taxes with no guarantee of a sustainable water supply. The proposed expenditure request from the Department of Water Resources (DWR) is made at a time when the state is struggling with the pandemic and economic recession. It also comes at a time when climate change suggests that dependence on imported water is less viable and less sustainable than ever.

**Instead of supporting the tunnel, we urge you to push the Department of Water Resources to help develop plans for meeting California's water demand without the tunnel.** Those projects would include improvements made to existing infrastructure around the state, and investments in local, sustainable water sourcing through conservation, groundwater remediation and recharge, water recycling, stormwater capture, and inland brackish water desalination. These improvements will make the need for the tunnel obsolete while creating local jobs and continuing to reduce water demand.

Dear Board Members of Valley Water:

At this week's board meeting, you have an opportunity to advance important planning and permitting work needed to advance the Delta Conveyance Project. I urge your support.

As you know, the State Water Project (SWP) provides the Santa Clara Valley with a reliable source of affordable, high-quality water. This water supply supports the local economy and enables technology, tourism, and agricultural industries to thrive.

As you continue the vital work of diversifying water supplies and boosting your local water resilience, we must continue to work together to maintain the reliability of water provided by the SWP that is the backbone of your region's water supply. SWP provides a reliable surface water source that enables water recycling and replenishment of groundwater aquifers to avoid subsidence and develop dry-year reserves. It provides critical water security as the district continues to explore new water supply sources which will lead to greater resilience.

Science tells us that surface water supplies for much of the state, provided by rain and snow runoff from the Sierra Nevada mountains and delivered through the SWP, are at risk. Climate change is bringing dramatic changes to our hydrology, including warmer, flashier storms with higher peak water flows. The SWP conveyance system faces risks from levee breaks, climate-driven sea level rise, saltwater intrusion, and earthquake. Modernizing conveyance through the Sacramento-San Joaquin Bay Delta—as well as other parts of the state—is critical to maintain system reliability in changing conditions.

Your leadership on this project has been integral to the progress made to date. The work you do as a part of the Delta Conveyance Design and Construction Authority has been invaluable, particularly your commitment to working with Delta communities to ensure transparency and openness as we advance planning and permitting for the project.
