# Virtual News Conference - Update on Anderson Dam Project

On December 16, staff hosted a virtual news conference regarding Anderson Dam and the Reservoir's lower water level. Director Varela provided opening remarks, Chief Operating Officer Aaron Baker discussed the water level reaching 3% capacity per the FERC order and Deputy Operating Officer of Dam Safety and Capital Delivery Chris Hakes gave a presentation on what's next for construction on the new outlet tunnel. Media in attendance included Morgan Hill and Gilroy Life, NBC Bay Area, KTVU and KQED.

## **Speaker Bureau Presentations**

Two speaker bureau presentations were provided to organizations from District 2. On December 2, Director Keegan hosted a presentation to members of the Temple Emanu-El, providing an overview of Valley Water's mission and goals. On December 14, Director Keegan offered opening remarks to the Kiwanis Club of San Jose, followed by a staff presentation.
