
Office of Communications Activities Summary for March 2021



Purified Water Project Scoping Meeting



On March 29, 2021, staff hosted a virtual public scoping meeting on the Purified Water Project. Chair Estremera and Director Santos delivered opening remarks to an audience of about 73 people. Vice Chair Kremen also participated in the meeting. Emceed by Assistant Chief Executive Officer Melanie Richardson, the meeting included an overview of the project, the planning process and how to provide feedback related to environmental impacts. Staff answered questions related to these topics and highlighted what to expect following the scoping meeting. The presentation video from that event has been viewed more than 200 times.

Water Supply Outlook Virtual News Conference

On March 16, Valley Water held a virtual news conference on the water supply outlook and conservation programs. Chair Estremera gave opening remarks, Chief Operating Officer Aaron Baker presented on current dry conditions heading into spring and Senior Water Conservation Specialist Karen Koppett discussed how residents and businesses can save water and money with Valley Water's conservation programs. The presentations were followed by a question and answer segment. Several media outlets participated including The Mercury News, KTVU, ABC7, KPIX, KCBS, and Morgan Hill and Gilroy Life.

Presentation to Gilroy Rotary Club

On March 23, Director Varela and Dep Op Ofcr Chris Hakes gave a presentation to 34 members of the Gilroy Rotary Club. The presentation included an update on the Anderson Dam Seismic Retrofit Project, and was well-received by the group.

During March, staff continued to produce and lead the biweekly Town Halls to provide employees with updates and bring awareness of resources, engagement opportunities, and other relevant items. In addition, staff supported the Emergency Operations Center activation with a variety of communications and outreach efforts.

Staff responded to media inquiries on the following topics:

- KTVU reporter Jana Katsuyama requested an interview on the reduction of the state water allocation. Staff sent her Chair Estremera's statement and Media & Public Relations Supervisor Matt Keller was interviewed.
- San Jose Spotlight reporter Carly Wipf interviewed Assistant Officer Kirsten Struve about the Purified Water Expansion Project negotiations with the City of San José.
- Freelance reporter Madelyn Reese interviewed Senior Biologist Janell Hillman about the Coyote ceanothus. Janell discussed when the work started, our partnership with other agencies and creating a whole new population of the species.
- NBC Bay Area reporter Damian Trujillo requested a statement from Valley Water for a story on the Alum Rock and Franklin McKinley School superintendents concerned about the unhoused camping in creek beds adjacent to schools. Staff sent him a statement from Interim Chief Operating Officer Sue Tippets.
- ABC7 News Reporter Wayne Freedman interviewed Media & Public Relations Supervisor Matt Keller on the importance of having a safe and reliable water supply, investing in infrastructure like the Anderson Dam Seismic Retrofit Project, the increasing costs that can come with drought and Valley Water's conservation programs.
- Politico reporter Debra Kahn interviewed Valley Water staff on the topic
 of drought and conservation. Assistant Officer Kirsten Struve and Water
 Supply Planning and Conservation Manager Metra Richert answered
 questions about the current dry conditions in our county and
 Valley Water's continued efforts to make conservation a way of life.
- Staff provided Mercury News Reporter Paul Rogers a statement on the March snowpack survey.
