# Anderson Dam Tunnel Project Pre-construction Update

On May 19, Valley Water hosted a virtual pre-construction meeting for the Anderson Dam Tunnel Project. Director Varela provided opening and closing remarks to the 75 people in attendance through Zoom and an additional 13 people via Facebook Live. The virtual meeting also included Valley Water staff who provided updates on the water supply, public safety and other aspects. The project is scheduled to start this summer.

### Launch of Drought Speakers Bureau

On May 20, Vice Chair Kremen launched the speakers bureau drought tour with a presentation to the Palo Alto Kiwanis Club. The presentation's focus is to provide information on the county's current drought condition, water supply outlook, water conservation programs and rebates, and updates on related projects, such as the Anderson Dam Seismic Retrofit. Vice Chair Kremen also presented to the Los Altos Kiwanis Club on May 25, and more presentations are in the process of being scheduled this summer.

# Leadership Morgan Hill Speakers Bureau Presentation

On May 20, Director Varela provided opening remarks and an overview of water supply in South County to the Leadership Morgan Hill group. The presentation provided information on current drought conditions, conservation efforts, and other projects. The presentation also included Vanessa De La Piedra, who discussed groundwater management; Stephen Ferranti and Melissa Moore, who provided information on the Upper Llagas Creek Flood Protection Project; and Chris Hakes, who presented an update on the Anderson Dam Seismic Retrofit Project to the group.

During May, staff continued to produce the monthly Town Halls to provide updates and bring awareness of resources, engagement opportunities, and other relevant items. In addition, staff supported the Emergency Operations Center activation with a variety of communications and outreach efforts.


