January 2020 Activities Update



Flood Awareness Campaign

The flood awareness advertising campaign continued with the delivery of the annual floodplain mailer to more than 50,000 homes and businesses in FEMA-designated flood zones. Several cities magnified our social media Get Flood Ready online campaign by sharing posts and videos on their social channels, along with newsletters. In addition, VTA has offered to post our Get Flood Ready message on their Tamien Station electronic sign through March 2020. Our videos in English, Spanish, Chinese and Vietnamese have been viewed about 260,000 times.

Staff created a winter preparedness guide and poster for residents and businesses located in high-risk flood zones. More than half of those recipients asked for electronic copies of those materials. So far, more than 300 of the fliers and 40 posters have been distributed. Outreach to these hot spots started in December and continued through January. Staff identified about 80 businesses, neighborhood organizations, schools, institutions, apartments and mobile home complexes in or near hot spots and conducted outreach to all prospective contacts.

X-Band Radar

Staff collaborated with local, regional, state and federal partners to coordinate a ribbon-cutting and media event unveiling the first permanent X-Band radar in the San Francisco Bay Advanced Quantitative Precipitation Information (AQPI) System. Staff prepared talking points for the event, which was emceed by CEO Norma Camacho and featured Director Richard Santos as a speaker. A joint press release was created with our partners and distributed to Bay Area media outlets, and the event received widespread coverage. Staff recorded a Facebook Live and posted a blog to *Valleywaternews.org*.

Media, Communications and Social Media

Staff wrote and posted six stories on valleywaternews.org on the following subjects:

Staff created a Division of External Affairs communication plan for the Safe, Clean Water and Flood Protection Renewal effort and wrote a CEO Message.

Guest columns were prepared for Director Kremen (water reuse agreement with the Cities of Palo Alto and Mountain View); Director LeZotte (highlighting some of Valley Water's work from 2019 and focusing on the environmental benefits of the Almaden Lake project); and Director Santos (celebrating the permanent installation of the first X-Band radar).

Staff created social media posts for an article from the U.S. Fish and Wildlife Service on Measure AA funds contributing to the "landmark effort," the South San Francisco Bay Shoreline Project. These posts are part of the Shoreline media plan highlighting the project.

Staff reached out to the Gilroy Dispatch and Gilroy Life about the completion of the Uvas Creek Levee Rehabilitation Project. The Dispatch requested photos and background information for a potential article.

Staff supported the Office of Civic Engagement by promoting online video and event post for the 2020 Career Job Shadow Day for Santa Clara County high school students.

The Gilroy Dispatch interviewed Director John Varela and Groundwater Management Manager Vanessa De La Piedra for a story on groundwater benefit zones.

Staff responded to media inquiries on the following topics: an artesian well underneath a condo in Santa Clara; the Anderson Dam Seismic Retrofit Project; work around the Anderson Dam spillway; Permanente Creek Flood Protection Project budget adjustment; instruments at dams that determine shifts or damage in an earthquake; and Sierra snowpack survey in relation to reservoir levels in Santa Clara County.

Staff prepared Nextdoor messages for board members on the following topics: Almaden Lake Draft Environmental Impact Report public meeting and community input; Emergency repairs coming to Almaden Valley Pipeline.
